This course is instructor led with 7.5 hours of teaching content via the Susan Harwood Grant program. Participants with responsibilities for the safe work of others around trenches and excavations

who are employed by construction companies with less then 250 employees may be eligible to become trainers and receive all curricula content with a commitment of

training at least 10 workers using the materials before the grant end date. All participants receive the Red Rocks Community College's **Digging Deeper** student manual; a 95-page document that has been approved for use in this program by US DOL OSHA. The manual illustrates safe industry practices aligned to the US DOL OSHA standards for working in and around trenches and excavations. Two dates are scheduled for September. <u>Register here</u>.

Voluntary Protection Programs

The OSHA Region VIII <u>Voluntary Protection Program</u> (VPP) relies heavily on our partners in the <u>Special Government Employee</u> (SGE) system to conduct VPP evaluations, assess annual reports, critique applications, provide outreach, and to con-

duct mentoring activities throughout the region. OSHA counts on the tremendous contributions of SGEs to help us keep VPP going strong. Each year OSHA recognizes a regional SGE whose work and support was truly exceptional. These awards are based on the previous calendar year, and are normally presented during the regional VPPPA conference. The conference was cancelled this year due to the pandemic, but OSHA would like to recognize and announce the OSHA Region VIII SGE of the Year for 2019 – Ms. Kathy Spanjer, CSP, from Schneider Electric.



In 2019, Ms. Spanjer participated in six (6) VPP evaluations. In

addition, she coordinated a VPP outreach and best practice sharing, presented a session on mentoring at the VPPPA conference, mentored six sites, evaluated five VPP annual reports, hosted a group of college students at her plant to teach them about safety/health and VPP, and presented an ergonomics training program to a group of manufacturers. Ms. Spanjer is an outstanding SGE whose work is always of the very highest quality. Everyone at OSHA is grateful for Ms. Spanjer's efforts to support employee safety and health excellence, the OSHA VPP, and the SGE program. As the recipient of the Region VIII SGE of the Year award, Ms. Spanjer was entered as a finalist for the OSHA National SGE of the Year.
